IF THE INSTRUCTOR IS LATE FOR A BEHIND THE WHEEL DRIVING APPOINTMENT PLEASE ALLOW FIFTEEN MINUTES BEFORE CONTACTING OUR OFFICE, AT TIMES TRAFFIC CONDITIONS, FLAT TIRES, ETC.. MAKE DELAYS UNAVOIDABLE.

DRIVING IN RAIN OR SNOW IS GOOD EXPERIENCE AND LESSONS ARE GENERALLY NOT CANCELLED. THE INSTRUCTOR WILL CONTACT THE STUDENT IF, IN HIS/HER OPINION THE STUDENT IS INCAPABLE OF DRIVING IN SUCH CONDITIONS.

STUDENTS WHO FAIL TO CANCEL AN APPOINTMENT A MINIMUM OF 24 BUSINESS HOURS IN ADVANCE SHALL BE CHARGED \$50.00. THE PARENT, LEGAL GUARDIAN OR THE PERSON HAVING CUSTODY, AND THE STUDENT SHALL BE JOINTLY LIABLE TO THIS AGREEMENT.
